### Primary energy use

The primary energy use for this property per year is 242 kilowatt hours per square metre (kWh/m<sup>2</sup>).

### Environmental impact of this property

This property's potential CO<sub>2</sub> production is 0.2 tonnes of CO<sub>2</sub> per year.

One of the biggest contributors to climate change is carbon dioxide (CO<sub>2</sub>). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO<sub>2</sub> emissions.

By making the [recommended changes](#), you could reduce this property's CO<sub>2</sub> emissions by 4.3 tonnes per year. This will help to protect the environment.

An average household produces 6 tonnes of CO<sub>2</sub> per year.
